In the Government in the G.M.2nd cited have informed the Principal Chief Conservator of Forests (HoFF) that keeping in view of the rule position, they have examined the representations of A.P. Forest Officers Association and considered that there is no need to revise the seniority list of the Assistant Conservators of Forests (SFS officers) as on 1-1-1999 to 1-1-2001, as prepared and communicated by the Principal Chief Conservator of Forests through letter dt.19-5-2008 and the appeal petitions / representations of the A.P. Forest Officers Association are rejected.

- In the above G.M. the Government have requested the Principal Chief Conservator of Forests to take immediate action for preparing the seniority lists for the subsequent years also, so as to comply with the court orders. Accordingly, provisional and final seniority lists as on 1-1-2002 to 1-1-2009 were communicated to all the concerned vide this office references 5th and 8th cited, respectively. Thus the seniority lists as on 01-01-2002 to 01-01-2009 has became settled one.
- Further, the Provisional Seniority Lists of Assistant Conservators of Forests (SFS Officers) as on 01-01-2010, 01-01-2011 and 01-01-2012 was prepared, based on the parameters / directions given by the Hon'ble Andhra Pradesh Administrative Tribunal in its order dated 17-4-1995 in R.P.No.3183/88, O.A.No.5534/92 and 5938/92 and as per the provisions of A.P. State & Subordinate Service Rules, A.P. Forest Service Rules and instructions issued by the Government from time to time and submitted to the Government for approval vide PCCF's reference 9th cited.
- The Government in the G.M. 10th cited have approved the provisional seniority lists of Assistant Conservators of Forests (SFS officers) as on 01-01-2010, 01-01-2011 & 01-01-2012 and permitted the Principal Chief Conservator of Forests (Head of Forest Force) to take action to communicate the same to all the concerned to put forth objection(s), if any, on the provisional Seniority List.

- 5. Accordingly, the Provisional Seniority Lists of Assistant Conservators of Forests (SFS officers) as on 01-01-2010, 01-01-2011 and 01-01-2012 are being communicated separately.
- 6. In view of the above position, provisional seniority lists of Assistant Conservators of Forests (SFS officers) as on 01-01-2013, was prepared, based on the parameters etc and as per the provisions of A.P. State & Subordinate Service Rules, A.P. Forest Service Rules and instructions issued by the Government from time to time and submitted to the Government for approval vide PCCF's reference 11th cited, duly following the procedure adopted for settled seniority lists 1-1-2002 to 1-1-2009 and provisional seniority lists as on 01-01-2010, 01-01-2011 and 01-01-2012.
- 7. The Government in the G.M. 12th cited have approved the provisional seniority lists of Assistant Conservators of Forests (SFS officers) as on 01-01-2013 and permitted the Principal Chief Conservator of Forests (Head of Forest Force) to take action to communicate the list to all the concerned to put forth objection(s), if any, on the said provisional Seniority List as on 01-01-2013.
- 8. In pursuance to the above orders, the provisional seniority list of Assistant Conservators of Forests (SFS Officers) as on 01-01-2013 is being communicated separately.
- 9. Consequent to amendment to A.P., Forest Service Rules, 1997 vide G.O.13th cited, draft Provisional Seniority List of Deputy Conservators of Forests (State cadre) as on 01-01-2014 and draft Provisional Seniority List of Assistant Conservators of Forests as on 01-01-2014 (as per provisions of APS&SS Rules, 96 & APFS Rules, 97 and instructions issued by the Government from time to time) were submitted to Government for approval duly justifying the reasons for preparation of said Seniority Lists separately.
- 10. The Government in the G.M.15th cited have approved the Provisional Seniority List of Deputy Conservators of Forests (State cadre) as on 01-01-2014 and Provisional Seniority List of Assistant Conservators of Forests as on 01-01-2014 and permitted the Principal Chief Conservator of Forests (Head of Forest Force) to take action to communicate the list to all the concerned to put forth objection(s), if any, on the said Seniority Lists.
- 11. Here, it is informed that there are typographical errors in placements in respect of Sri D.Bheema, Smt T. Jyothi, Dr.B.Prabhakar and K.Ashok Kumar Deputy Conservators of Forests (State cadre) in the provisional seniority list as on 01-01-2014 and accordingly the same has been informed to the Government vide PCCFs Ref.No.6073/2014-M.4, dt.30-05-2014. A copy of which is also enclosed herewith for information of all the individuals.
- 12. In pursuance to the above orders, the Provisional Seniority List of Deputy Conservators of Forests (State cadre) as on 01-01-2014 and Provisional Seniority List of Assistant Conservators of Forests as on 01-01-2014 are communicated herewith.
- 13. The Deputy Conservators of Forests (State cadre) and Assistant Conservators of Forests are requested to put forth objection(s), if any, on the Provisional Seniority List of ACFs as on 01-01-2014 and Provisional Seniority List of Deputy Conservators of Forests (State cadre) as on 01-01-2014 within a period of (15) days from the date of deemed communication of the list. The said seniority lists has been kept on the departmental web site and as such it is considered that the said communication is to be treated as deemed communication.

They are requested to acknowledge the receipt of this Provisional seniority lists in the form enclosed.
