Sub: Execution of works by Forest Department with funds
of other departments - instructions issued.

The Government allot funds to Forest Department for implementing social forestry works under various programmes such as National Rural Employment Programme, Drought Prone Area Programme, Integrated Rural Development programme, PASMA, Drought Relief works etc., Instructions were issued in this office Rc. No. 119354/85-S2, dated. 3.4.1985, for submitting perspective master plans and Annual plans and obtaining technical sanction from the Chief Conservator of Forests, before placing the plans before the District Planning Board/Social Forestry Committee and before taking-up works under the above schemes in the districts.

2. In addition to the above, the Roads & Buildings, Irrigation and other Departments have been placing their funds at the disposal of the Forest Department for social forestry programme etc. along the roads, canal bunds, and projects under their control.

3. Adequate funds are available with this department under various schemes and the Chief Engineers of the Roads and Buildings, Irrigation Department etc., were informed in this office ref.No.30743/84-U4, dt.22.2.1985 that funds from their departments are not required for the works to be executed by this department.

4. Therefore, all the Conservators of Forests and Divisional Forest Officers are hereby requested not to accept funds of other departments/or Institutions for any works without specific clearance from the Chief Conservator of Forests. This does not apply for funds mentioned in para 1 above.
